
NOTICE OF PROPOSED MAJOR UTILITY FACILITY

AEP Ohio officials have proposed an electric transmission project in Harrison Township, Licking County, Ohio

AEP Ohio representatives plan to build approximately .2 miles of 138-kilovolt (kV) transmission, extending southwest out of Kirk Substation off Watkins Road Southwest in Harrison Township, Licking County. The new line provides power between the Union Ridge Solar Facility and the Kirk Substation to provide a connection for the generation facility's power delivery.

AEP Ohio Power Company filed a Letter of Notification for this project with the Ohio Power Siting Board (OPSB) as the Kirk-Union Ridge Solar 138-kV Transmission Line Project, Case. No. 22-1067-EL-BLN. The Letter of Notification to construct, operate and maintain this facility awaits OPSB review. If approved, company representatives expect construction to begin spring 2023 and conclude summer 2023. The OPSB accepts motions to intervene in the Letter of Notification up to 10 days following the publication date of this notice. The requirements to intervene are included



in Rule 4906-2-12 of the Ohio Administrative Code. Please address motions to Ohio Power Siting Board, 180 E. Broad St., Columbus, Ohio, 43215-3793 and cite Case No. 22-1067-EL-BLN.
