


# NOTICE OF PROPOSED MAJOR UTILITY FACILITY

**AEP Ohio officials have proposed an electric transmission project in New Albany and Jersey Township, Licking County.**

AEP Ohio representatives plan to build a new 345-kilovolt (kV) substation near the intersection of Johnstown-Utica Road and Beech Road in New Albany, Licking County. The company needs to build Bermuda Substation to serve a customer's facility and meet the area's growing electrical load demand. If approved, crews plan to start construction in May and conclude by late 2025. AEP Ohio representatives have filed the Letter of Notification with the Ohio Power Siting Board (OPSB) as the Bermuda 345 kV Station Project, Case No. 25-0046-EL-BLN. The Letter of Notification to construct, operate and maintain this facility awaits OPSB review. The OPSB accepts motions to intervene in the Letter of Notification up to 10 days following the publication date of this notice. The requirements to intervene are included in Rule 4906-2-12 of the Ohio Administrative Code. Please address motions to Ohio Power Siting Board, 180 E.
