

NOTICE OF PROPOSED MAJOR UTILITY FACILITY

Representatives of AEP Ohio Transmission Company, Inc. plan to build 1.6 miles of 345-kilovolt (kV) power line connecting Cyprus Substation off Parsons Avenue to an existing 345-kV line near OH-317. Company representatives need to build the transmission line to serve a customer's facility and meet the area's growing electrical load demand.

Company representatives have filed a Letter of Notification for the project with the Ohio Power Siting Board (OPSB) as the Cyprus 345 kV Extension Project, Case No. 24-0175-EL-BLN.

The Letter of Notification to construct, operate and maintain this facility awaits OPSB review. The OPSB accepts motions to intervene in the Letter of Notification up to 10 days following the publication date of this notice. The requirements to intervene are included in Rule 4906-2-12 of the Ohio Administrative Code. Please address motions to Ohio Power Siting Board, 180 E. Broad Street, Columbus, OH, 43215 and cite Case No. 24-0175-EL-BLN.
