## NOTICE OF PROPOSED MAJOR UTILITY FACILITY

AEP Ohio representatives plan power upgrades to support increasing electricity demands in Vinton County. The Ilesboro Improvements Project involves building 1.5 miles of 138-kilovolt (kV) transmission line and installing Fiddlestix Switch near the existing Poston-Ross 138-kV transmission line. The project provides power to South Central Power's Ilesboro Substation on State Route 93 by connecting the new substation to the power grid. Creating a stronger transmission network improves the operation of the power grid and prepares the grid for a projected increase in electricity demand.

AEP Ohio Transmission Company and Ohio Power Company representatives filed a Letter of Notification and Construction Notice with the Ohio Power Siting Board (OPSB) as the Fiddlestix Switch-Ilesboro South Central Power 138-kV Transmission Line Project, Case No. 23-0123-EL-BLN and Fiddlestix Switch & Poston Ross 138-kV Cut-In Project, Case No. 23-0122-EL-BNR. The Letter of Notification and Construction Notice to construct, operate and maintain this facility awaits OPSB review. If approved, construction begins in May and concludes in late 2023.

The OPSB accepts motions to intervene in the Letter of Notification and Construction Notice up to 10 days following the publication date of this notice. The requirements to intervene are included in Rule 4906-2-12 of the Ohio Administrative Code. Please address motions to Ohio Power Siting Board, 180 E.
