


NOTICE OF PROPOSED MAJOR UTILITY FACILITY

AEP Ohio representatives plan to build Jorden Substation near the intersection of Clover Valley Road Northwest and Mink Street in New Albany. Company representatives need to build the substation to serve a customer's facility and meet the growing electrical demand in the area. If approved, construction begins early 2026 and concludes summer 2026.

AEP Ohio officials filed a Letter of Notification with the Ohio Power Siting Board (OPSB) for this project as the Jorden 138kV Station Project, Case No. 25-0941-EL-BLN.

The Letter of Notification to construct, operate and maintain this facility awaits OPSB review. The OPSB accepts motions to intervene in the Letter of Notification up to 10 days following the publication date of this notice. The requirements to intervene are included in Rule 4906-2-12 of the Ohio Administrative Code. Please address motions to Ohio Power Siting Board, 180 E. Broad St, Columbus, OH, 43215 and cite Case No. 25-0941-EL-BLN.
