

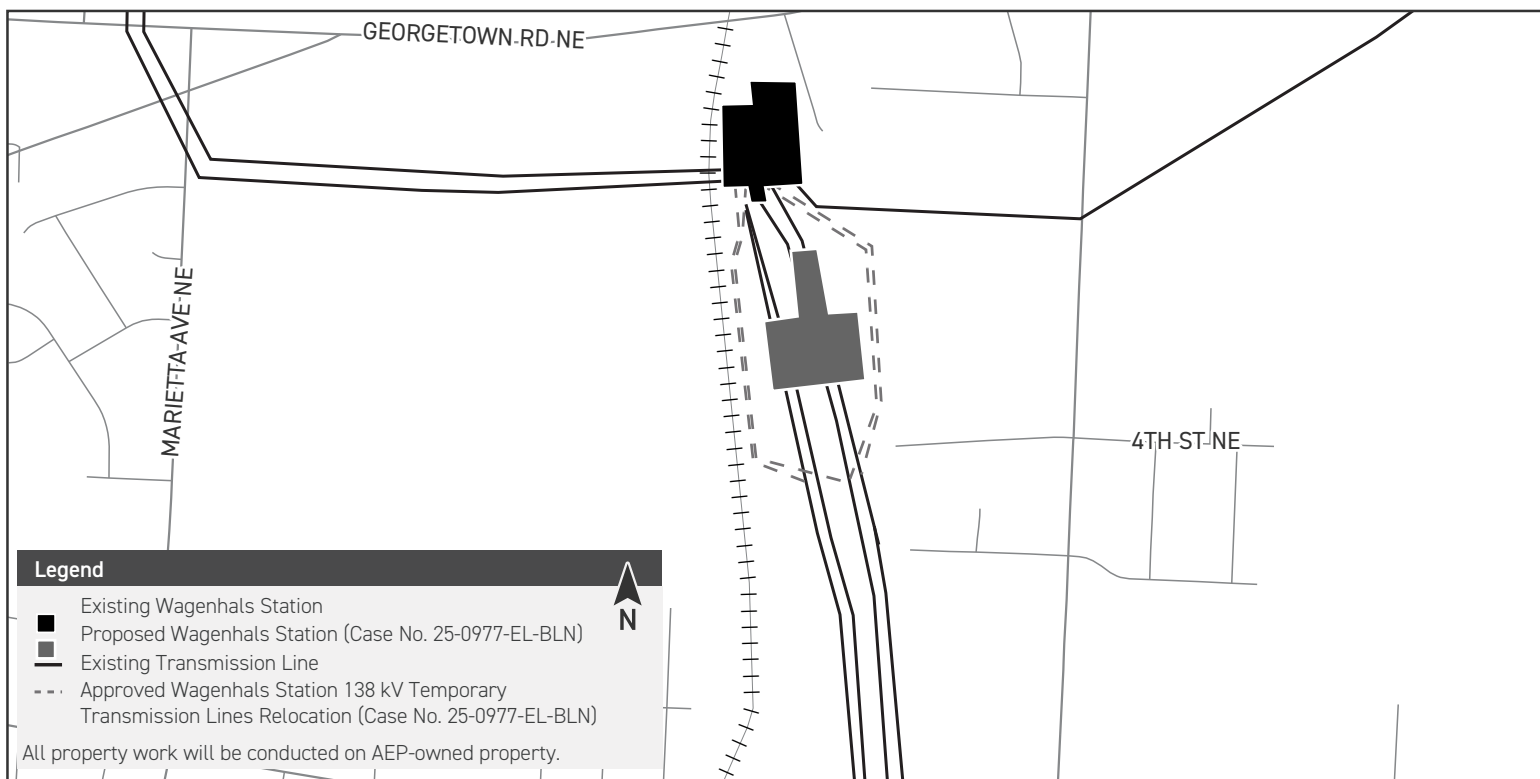
NOTICE OF PROPOSED MAJOR UTILITY FACILITY

AEP Ohio Announces Station Rebuild in Stark County

AEP Ohio plans to rebuild the Wagenhals 138-kilovolt (kV) Station at a greenfield location immediately south of the existing station off Georgetown Street Northeast in Canton. The work is part of the Wagenhals 138 kV Station Rebuild Project in the City of Canton, Stark County, Ohio.

The improvements support AEP Ohio's ongoing efforts to enhance electric service reliability and meet future energy needs in the region.

If approved, construction of the new Wagenhals Station is expected to begin in January 2026 and conclude in summer 2027.



The Letter of Notification to construct, operate and maintain this facility awaits Ohio Power Siting Board (OPSB) review. The OPSB accepts motions to intervene in the Letter of Notification up to 10 days following the publication date of this notice. The requirements to intervene are included in Rule 4906-2-12 of the Ohio Administrative Code. Please address motions to Ohio Power Siting Board, 180 E. Broad Street, Columbus, OH, 43215 and cite **Case No. 25-0977-EL-BLN**.
